

TOWN OF PACKWAUKEE
2024 Annual Town Meeting Minutes
Tuesday, April 16, 2024, at 6:00 p.m.

Called to order at 6:00 p.m. by Chair Lance Achterberg

Pledge of Allegiance was said.

Motion by Courtney Trimble, seconded by Adam Schuh to vote by hand. Motion passed unanimously.

- 1) Motion by Adam Schuh, 2nd by Janny Slama to approve the minutes of the April 18, 2023, annual town meeting. Motion passed unanimously.
- 2) Clerk's 2023 financial report read
- 3) Treasurer's 2023 tax roll report read
- 4) Citizen Inquiries:
 - a) Discussion around lawnmowing and obnoxious weed ordinance. Letters are sent out to property owners who are in violation.
 - b) Question about the use of mini-bikes and go-karts on the town roads. It was noted this is not allowed on town roads.
 - c) Discussion about the Causeway closing.
 - d) Discussion about geese being on highways and cars not stopping for them. Discussion about putting signage up on roads to protect geese. Courtney Trimble indicates she will put a message on the website.
 - e) Discussion about putting the new kiosk up at the dump. Chair indicates the kiosk will be put up this spring.
 - f) Discussion about there being issues with woodchucks at Oak Hill Cemetery. Vikki will investigate.
 - g) Discussion that constituents believe there is a speeding issue in Packwaukee. Motion by Mike Marine for the board to do something about documented speed issue on highway C and D, 2nd by Wendy Robiner. All in favor and motion passed. Schuh noted that it is not actionable and enforceable but advisory to the board.
 - h) Discussion about numbered board seats. Motion by Adam Schuh that the board adopt a plan to elect town board supervisors to numbered seats, supervisors being elected in odd years to be Supervisor 1 and 3, supervisors being elected in even years to be Supervisor 2 and 4, 2nd by Vikki Trimble. After long discussion, Adam Schuh requested the chair call the vote.
