Meeting date was changed due to recall election on Tuesday July 12, 2011 Chairman Don Hall called meeting to order at 6:00 p.m. Pledge of Allegiance

Meeting Minutes: Motion by Jim Sanders seconded by Vikki Trimble to approve the minutes from the June 14, 2011 Town Board Meeting as read. Motion Carried.

<u>Treasurer's report:</u> Treasurer Jeri Showers read the treasurers report. Motion by Al Rosenthal seconded by Vikki Trimble to approve the treasurers report as read. Motion Carried.

Citizen Inquiries and Concerns: Assessor, Jim Warzynski, was unable to attend the board meeting. Vikki Trimble will contact him to see if he can attend the August town meeting to discuss the Bond's issue. Tabled until the August meeting. Concerns about Moon Lake/Birch Lake with a no motor ordinance. This will be put on the agenda for the August meeting. Bert Lietzow was at the meeting and complained about golf carts, trespassers on his property, ect. He stated his property is under an ok with zoning. Jim Sanders met with zoning and Bert and it was ok at that time. County has issued a citation since June 19th. Jody Bowman asked if the Historical Society could store a large tent in the town garage. Jim Sanders will look into having parking lines painted in front of Tom Bowman's Building on Liberty Street. Tom McGill will install 3 deadbolts for no more than \$300.00 for the Library door, office door and the handicap. Per the GAB we need two cones set out for the blind and a doorbell for the handicap. Motion by Al Rosenthal seconded by Vikki Trimble to be in compliance with the GAB. Motion Carried. Motion by Al Rosenthal seconded by Dale Walters that the horseshoe pits are put up for the Picnic only. Motion Carried. Roads: Dale Walters and Al Rosenthal will be going on an Intersection Visibility check. Clerk Janny Slama wrote a letter to Steve Wojnowski and Jim Sanders delivered it and explained what can be done about the culvert. Steve Wojnowski wrote a letter back and wanted the town to fix it and put it on his taxes.

Rail Road: Neil Johnson reported that he has to contact other sources for the RR Bridge.
