**Regular Town Board Meeting**

In attendance: Lance Achterberg, Vikki Trimble, Judi Nigbor, Keith Bagley, Larry Haygood, Courtney Trimble-Clerk, Jeri Showers-Treasurer

Called to Order at 6:00 p.m. by Chairman Lance Achterberg

- Motion by Vikki, seconded by Larry to approve the minutes of the May 10, 2022 meeting. Motion carried.

- Clerk's Report give.

- Treasurer's report read.

- **Library Report:** Sheriff's Office wants to make fishing with the deputies, now called Cops and Bobbers, an annual event.

- **Citizens Inquiries and Concerns:**

- Concern regarding someone living in a camping trailer year round. This is dependant on zoning.

- Concern by Dennis Hurckman regarding a resident running a generator 24 hours a day. Lance is going to touch base with the Sheriff's Office to see if they are able to do anything about it.

- Concern by Janny Slama regarding old flowers being piled up at the cemetery and the grave digger is not reusing the sod they remove. Vikki will mention this to Mike Crawford to make sure the sod is being reused.

- Concern by Gina Arnieri about electrical boxes being installed at the failed site of the gravel pit. This is unrelated to the gravel pit.

- Concern by Keith Bagley regarding a child who was putting his books in the outside book return at the library and he was screamed at by Mrs. Hurckman who lives across the street. He ran home and his mother called the police. This is the not the first time this has happened. Judi would like to see the police report.

- Clerk Trimble was contacted by multiple citizens regarding the "billboard" that is going up at the corner of Freedom Road and County D. The campground owns this and is working with the highway department to put it in a convenient location.

- Motion by Keith, seconded by Larry to approve an operators license for Randy Hellenbrand II. Motion carried.

- Motion by Vikki, seconded by Keith to approve operators licenses to Blanche Flurette, Kathleen Pratt, Mary Tomlinson, Rick Rhode, Sandra Bobzien, Theresa Yanke, and Laura Vickers. Motion carried.
- Motion by Keith, seconded by Vikki to approve a combination beer/liquor license renewal for Wingers Starlite Lodge. Motion carried.
- Motion by Larry, seconded by Keith to approve a soda license for Wingers Starlite Lodge. Motion carried.
- Motion by Vikki, seconded by Keith to approve a beer license for Lakeview Campground & Bar. Motion carried.
- Motion by Keith, seconded by Larry to approve a wine license for Lakeview Campground & Bar. Motion carried.
- Motion by Larry, seconded by Keith to approve a soda license for Lakeview Campground & Bar. Motion carried.
- Motion by Vikki, seconded by Keith to approve operators licenses for Cindy Chadwick, Jeff Corning, Kimberly Vangen, and Jonathan Vangen. Motion carried.
- Motion by Keith to approve a combination beer/liquor license for Weekendz. Failing to hear a second this motion died on the floor.
- Motion by Larry, seconded by Vikki to deny a combination beer/liquor license to Weekendz for failure of the business to be open sufficient enough to comply with Packwaukee Ordinance Sec. 7-2-16. Motion carried 4-1.
- Motion by Vikki, seconded by Larry to approve a soda license for Weekendz. Motion carried.
- Motion by Vikki, seconded by Larry to approve a temporary picnic license for the Historical Society for Heritage Days. Motion carried.

- **Recycling Center:** The causeway project has been put on hold until at least next year. Motion by Vikki, seconded by Larry to table to discussion regarding the site on the south side of the lake until the causeway project is back on. Motion carried.

- **Roads:** Judi will follow up with Brian regarding the shoulders on County C. Motion by Keith, seconded by Larry to hire the county to mow the town roads at a cost of \$12,000. Motion carried. Motion by Judi, seconded by Keith to approve the county road plan from Brian with the exception of the paving of 11th drive for a total cost of \$106,500. Motion carried.

- **Town Hall, Park, Flags, Boat Landings, Christmas Decorations:**

- Larry got a bid from Emonds Construction to fix the siding for \$7395.88. ABC Builders came in at a cost of \$3400.00 or \$850 for just one side of the building. They will be asked to provide an updated quote with higher quality materials.

- Larry is going to redo one of the Christmas decorations to see how it looks.

- Motion by Vikki, seconded by Keith to allow the Historical Society to temporarily store things from the Muir shed in the park shed during Heritage Days so they can open the Muri shed to the public. Motion carried.

- **Packwaukee Land Use Planning Commission:** Motion by Vikki, seconded by Larry to approve the after the fact variance request upon recommendation from the Plan Commission. Motion carried 4-0 with Chairman Achterberg abstaining.

- **Lake Commission Reports:**

- Buffalo: Started cutting but already lost a few days to lightning. The chair has stepped down and Al Rosenthal is covering it in the interim until their October election.

- Emery: Has not met.

- Williams: They are looking for harvester operators.

- **Firewise:** Had their program at Lake Emery regarding driveway accessibility for fire trucks and ambulances. They are working with landowners to get tree branches cut with a grant that was received. Dick Daniels will be

doing the work some time this fall. This is the 5th and final year for the Firewise program and it will be up to the town if they want to do another 5 years.

- **Old Business:**

- Veterans Memorial Project: Historical Society is talking about doing fundraisers at Heritage Days. They are hoping to stock money away until material prices come down. Keith will also be applying for ARPA funds from the county.
- Healthy Lakes Grant Updated - Karyn met with Pat Kilby who stated he would not approve the grant for the initial area the board wanted planted because the purpose of the wild flower garden is to stop runoff into the lake. Motion by Larry, seconded by Keith to approve the area to the immediate east of the launch for planting. Motion carried.
- Wisconsin to Church St Alleyway Vacation: Waiting on information from Jesse.
- Audit/Review: Clerk Trimble has been speaking with Kerber Rose and they are supposed to be giving her some dates that will work and sending a materials list.

- **New Business:**

- Appointment of interim clerk - no applications received. Courtney Trimble states she will continue doing the job until a replacement can be found or the April 2023 election occurs.
- Motion by Vikki, seconded by Larry to adjourn the meeting at 7:59 p.m.
